The Trial Secretary is not responsible for emails not received. If you have not received a response to an email after 24 hours, please call the Trial Secretary by telephone.

The safety of the dogs is our primary concern. By entering these trials, exhibitors acknowledge that they are familiar with the rules and regulations of this sport.

<u>Entry fees will not be refunded</u> in the event that a dog is absent, disqualified, excused, or barred from competition by action of the Trial Committee.

Entry fees will not be refunded if the trials cannot be opened or completed by reason of riots, civil disturbance, fire, an act of God, public emergency, an act of a public enemy, covid, or any other causes beyond the control of Greater St. Louis Training Club Inc.

Entries must be made on Official AKC Entry Forms or copies and must include the signed Agreement and Rules.

Junior Handlers must complete the back of the entry form. Please include only AKC titles on your entries.

No entry shall be made and no entry shall be accepted which specifies any condition as to its acceptance. Entries will not be accepted without fees or signatures.

Post Dated and Returned checks do not constitute a valid entry fee. There is a \$25 returned check fee.

Since bitches in season are not allowed to compete in AKC Obedience/Rally Trials, the club will refund all but \$8.00 of the entry fee per trial for bitches unable to compete for that reason. The Trial Secretary must receive written notification from a Veterinarian of such a claim not later than 30 minutes before the start of judging of the first class in the trial.

It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee be asked to leave the trial site. In such case, no refund of any fees paid will be made.

All dogs must always be on lead or crated except when in the ring. All "warm ups" MUST be done ON LEAD. The lead is attached to the dog's collar and the handler is holding the lead.

Exhibitors are responsible for cleaning up after their dogs at the show site and all hotel, motel, and campgrounds where they are staying while competing in these trials.

Exhibitors are responsible for being at the ring gate when it is their turn to run. The judge need not wait for any dog holding up a class. Greater St. Louis Training Club Inc. has no obligation or responsibility for providing service through a public address system or steward for the purpose of calling or locating dogs that are not brought to the ring when required.

Owners are responsible for errors in making out entry forms, whoever may have made such errors. No entry will be refunded in the event of such errors or cancellation of entries after the published closing date. Errors in entries made by the exhibitor cannot. be corrected after the closing date other than change from A to B with written request and move ups.

No refunds for duplicate entries.

Exhibitors should follow their veterinarians' recommendation to assure their dogs are free of internal and external parasites, any communicable diseases, and have appropriate. vaccinations.

Refer to Chapter 1 Section 14 of the Obedience Regulations for further restrictions. Refer to Chapter 2 of the Registration and Discipline Rules for the listing of registrable breeds that may participate.

Missouri state law requires all dogs participating in dog shows be free of clinical signs of infectious or contagious disease and must be vaccinated for rabies; dogs traveling from outside of the state are also required to have a certificate of veterinary inspection.

- 2. The following categories of dogs may be entered and shown in Best of Breed competition: Dogs that are Champions of Record and dogs which according to their owners' records, have completed the requirements for a championship, but whose championships are unconfirmed. The showing of unconfirmed Champions in Best of Breed competition is limited to a period of 90 days from the date of the show where the dog completed the requirements for a championship.
- 3. (Event Class) Consult the classification in this premium list. If the dog show class in which you are entering your dog is divided, then, in addition to designating the class, specify the particular division of the class in which you are entering your dog, i.e., age division, color division, weight division.
- 4. A dog must be entered in the name of the person who actually owned it at the time entries for an event closed. If a registered dog has been acquired by a new owner, it must be entered in the name of its new owner in any event for which entries closed after the date of acquirement, regardless of whether the new owner has received the registration certificate indicating that the dog is recorded in his/her name.
